City Council Actions

Since November 14 Johns Creek City Council has

- Held Six Meetings
- Adopted 36 Resolutions
- Adopted 35 Ordinances

Actions include IGAs, City Code, legal organ, leasing of office space, annexation, collection of taxes, solid waste services, code enforcement, roadway evaluations, as well as obscenity, S.O.B., and adult entertainment ordinances.
